After the Membership Chairman validates the information provided on the application form, the Board of Directors (BOD) will vote to accept (approval by majority vote) the organization as a member.

Individual Membership: Once an organization is a member of the FFRDC/UARC Security Council, designated employees may submit a FFRDC/UARC Security Council Membership Application Form to the Membership Chairman. Any exceptions must have the approval of the BOD. All vetted and approved individual members are entitled to hold elective office, participate in the FFRDC/UARC Security Council business, attend meetings, and serve on Sub-Working Groups and Research Teams.
